## MRNLIW Fundraising Guidelines

As MRNLIW you are responsible for all expenses associated with your title. You may seek out sponsors and financial support for your reign. MRNLIW may not contact any sponsors secured by the reigning MRN or the Miss Rodeo Nevada Association.

1. All funds received must be turned into the Miss Rodeo Nevada Treasurer for bookkeeping purposes.
2. All funds will be accounted for in a separate line item in the Miss Rodeo Nevada financial report under MRNLIW/MRN.
3. All funds will become available for use upon execution of the MRN contract.
4. A special request may be made in writing for use of funds prior to that contract execution. The Miss Rodeo Nevada Association will convene to accept or reject such written request.
5. It is expressly understood that upon you assuming the title of MRN, you will be entitled to 80% of all your donated funds that are secured and MRNA will be entitled to 20% of these funds.
6. Any sponsorship secured or monetary donations made will not be made public until you execute the MRN contract.
7. As MRNLIW you will create your own sponsor package that obligates you to your personal sponsors. MRNA will not be held responsible for these sponsorship obligations except to include them on our website or autograph page upon the execution of the MRN contract.
8. Upon taking the title of MRN, if sponsor logos are to be used during your reign as MRN, you will incur the cost for the use of your personal sponsor logos etc. MRNA will incur the cost for the Association sponsors.
